DESCRIPTION.

Kingfisher KF-8 DUAL PURPOSE MICROEMULSION CONCENTRATE is the latest generation, aqueous, timber treatment in a concentrated form which, when diluted, gives a virtually odourless, long lasting, deeply penetrating micro-suspension. The product is an aqueous blend of non-ionic surfactants and an active ingredients formulated specifically for the eradication of common furniture beetle and wood boring insects PLUS control of wood destroying fungi.

ADVANTAGES.

- Non flammable.
- Effective against all wood destroying fungi.
- Non hazardous.
- Surfactants ingredients are non hazardous and biodegradable.

AREAS of USE.

Kingfisher KF-8 DUAL PURPOSE has been specifically formulated for the in situ treatment of timber which is affected by wood boring insects and decay fungi.

Note: - The treatment of Longhorn House Beetle and Death Watch Beetle or heavy section timber must be supplemented where necessary to provide additional protection. (Refer to **Kingfisher Timber Paste** data sheets)

APPLICATION.

Diluted **Kingfisher KF-8 DUAL PURPOSE MICROEMULSION CONCENTRATE** can be applied using a brush or low pressure spray.

Before applying any preservative treatment, ensure that the areas to be treated are adequately exposed and clean.

Remove any heavily infested wood and loose dust, preferably by vacuuming.

When treating roof spaces, remove (or roll up and cover) any thermal insulation materials present to provide unhindered access to all joists and timbers.

Cover water storage tanks with heavy grade polythene which should be left in place after treatment.

Cover electrical junction boxes etc. and isolate power supplies during and after treatment, until treated area has dried out.

***ONE HOUR RE-ENTRY Controls**

EXCLUDE ALL UNPROTECTED PERSONS AND ANIMALS DURING TREATMENT AND FOR AT LEAST 1(One) HOUR AFTER TREATMENT IS COMPLETED. ENSURE THERE IS A PHYSICAL BARRIER TO PREVENT CONTACT BY UNPROTECTED PERSONS AND ANIMALS UNTIL THE TREATED AREAS ARE VISIBLY DRY.

Dip.

Dip wood in diluted product for a minimum of 3 minutes.

MIX INSTRUCTION.

Pour approximately 10 litres of water into a clean 25 litre container and add 2 litres of **Kingfisher KF-8 DUAL PUPOSE MICROEMULSION CONCENTRATE.**

Top up the container to 25 litres with water and mix.

2 litres of Kingfisher KF-8 Concentrate will make 25 litres of ready to use solution.

COVERAGE.

1 litre covers 3 to 4 sq. metres (depending on porosity)

PACKAGING.

Kingfisher KF-8 MICROEMULSION INSECTICIDE is supplied in 4 litre graduated plastic containers. (Produces 50 litres)

HEALTH and SAFETY.

Statutory conditions relating to use of Kingfisher KF-8 Dual Purpose Micro emulsion.

- For use only as a wood preservative.
- The Control of Substances Hazardous to Health (COSHH) Regulations 2002 may apply to the use of this product at work.
- **FOR USE BY PROFESSIONAL OPERATORS.**
- Engineering control of operator exposure must be used where reasonably practicable in addition to the following items of Personal Protective Equipment (PPE); Face mask with A2P3 type filters, protective overalls, gloves and eye protection.
- Take off immediately any contaminated clothing
- Avoid excessive contamination of overalls and launder regularly.
- **DO NOT** breathe spray mist, otherwise wear respiratory protective equipment and eye protection.

- Engineering controls may replace PPE if a COSHH assessment shows that they provide an equal or higher standard of protection.
