4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

4. FIRST AID MEASURES (ACTION)

5. FIRE – FIGHTING MEASURES

- Extinguishing media:** All standard fire fighting media for surrounding fires.
- Exposure hazards:** A waterborne product which will not support combustion in the uncured state. However, this product does contain combustible organic components which will eventually yield smoke containing hazardous products of combustion on ignition.
- Protection of fire-fighters:** Fire-fighters should wear self contained breathing apparatus and suitable protective clothing.

6. ACCIDENTAL RELEASE MEASURES

- Storage conditions:** Store in a cool, dry well ventilated area. Protect from frost. Keep containers tightly closed. Avoid temperatures below 5°C. Keep out of reach of children.
- Suitable packaging:** Must be kept in original packaging.
